

# PUBLIC COMPETITION ANNOUNCEMENT FOR ADMISSION TO THE 40TH CYCLE DOCTORAL RESEARCH COURSE

# ART. 1 – ACTIVATION AND CHARACTERISTICS OF THE DOCTORAL RESEARCH PROGRAM

1. This announcement governs the modalities of access to the associated Doctoral Research program in "COGNITIVE DESIGN: INTEGRATED EVOLUTION OF HUMAN AND TECHNOLOGY IN THE NEW PRODUCTIVE ERA (DOT249W3PP)", with the administrative headquarters at ISIA Higher Institute for Artistic Industries of Florence, and developed in association with ISIA Higher Institute for Artistic Industries of Rome.

2. The duration of the doctoral program is three years, with a planned start date of November 1, 2024, and it offers 3 positions with scholarship D.M. 630/24 (Mission 4, component 2, Investment 3.3, resources allocated for the co-financing of doctoral scholarships for dedicated programs with the contribution and involvement of companies) and one position without a scholarship.

3. The educational activities related to the doctoral program will be conducted at the headquarters of ISIA Higher Institute for Artistic Industries of Florence, as well as at the partner institutions and other locations that will be identified by mutual agreement according to the research needs.

4. The submission of the application for admission, according to the procedures referred to in Art. 3, implies the acceptance by the candidates of the rules contained in this announcement.

5. The use of the masculine gender in this announcement is not intended to be discriminatory but is used as a neutral gender for the sake of more immediate communication.

## **ART. 2 – ADMISSION REQUIREMENTS**

Applications for participation in the competition can be submitted, without age and citizenship restrictions, by those who, at the deadline of the announcement, possess one of the following academic qualifications:

- master's degree obtained pursuant to D.M. 270/2004;
- specialist degree obtained pursuant to D.M. 509/1999;
- degree obtained under the educational systems prior to D.M. 509/1999, with a legal duration of at least four years;
- second-level academic qualification issued by Institutions of Higher Artistic, Musical, and Coreutic Education (AFAM) or equivalent (Previous System combined with a high school diploma);
- academic qualification obtained from foreign universities equivalent to the Italian qualification required for access.

Those who will obtain one of the aforementioned qualifications by October 12, 2024, may also apply. In such cases, the candidate will be conditionally admitted and must send a self-certification of the attainment of the





qualification to the Doctorate Office: dottorati@isiadesign.fi.it within 5 days from the date of obtaining the degree. Failure to submit the aforementioned self-certification within the specified timeframe will result in exclusion from the ranking.

## **ART. 3 – APPLICATION FOR PARTICIPATION**

1. The application for participation in the doctoral course must be sent exclusively to the Certified Email Address (PEC): segreteria@pec.isiadesign.fi.it by 12:00 PM (Italian time) on September 9, 2024.

2. The candidate must fill out the application form using exclusively the "Application Form" and indicate, under penalty of exclusion:

- personal details;
- whether they intend to take the interview in Italian or English;
- whether they are or are not an employee of Public Administrations;
- that they have not already benefited from doctoral scholarships in Italy, even partially.

3. The following must be attached to the application:

3.1. the qualifying titles, under penalty of exclusion:

#### a) FOR QUALIFICATIONS OBTAINED IN ITALY

Self-certification (specialist/master's degree or second-level single-cycle AFAM diploma), degree/diploma grade with any thesis title;

#### b) FOR QUALIFICATIONS OBTAINED ABROAD

Candidates holding a foreign academic title (equivalent to a specialist/master's/old-system degree, second-level AFAM diploma) may apply for admission by attaching the obtained qualifications, accompanied by a translation in Italian or English. These candidates are admitted to the competition with reservation and will be excluded from the competition, or, if they pass, from the doctoral course they are enrolled in if, upon verification, it is found that the title does not meet the requirements of this call and thus does not allow enrollment in the doctorate.

Specifically, the foreign academic title must be comparable in duration, level, and disciplinary field to a second-level Italian academic title. The suitability of the foreign title, if not already recognized under current legislation, is verified by the PhD admission committee, solely for the purpose of access to the competition, in accordance with the legislation in force in Italy and the country where the title was awarded, as well as international treaties or agreements on the recognition of qualifications for further studies.

Before the start of the courses, the translated and legalized qualifications in Italian must still be submitted to the Doctoral Office along with the enrollment application, accompanied by a "Dichiarazione di valore in loco" issued by the competent Italian representations in the country where the title was obtained. Alternatively, the comparability and verification certificates of the foreign university title issued by the ENIC-NARIC center in Italy (CIMEA), containing all necessary information for the evaluation of the qualification, can be submitted. For qualifications obtained in an EU country, the diploma supplement is sufficient. For entry into Italy, non-EU citizens residing abroad must register on the Universitaly portal and request an entry visa (post-graduate type D visa) from the Italian Embassy or Consulate competent for their territory.

3.1.2 The following attachments are mandatory for the application, under penalty of exclusion:

a) a copy of a valid identity document or passport;









**b)** curriculum vitae et studiorum (in European format) in Italian or English, signed under Articles 46 and 47 of DPR 445/2000 and subsequent amendments;

c) receipt of payment of the non-refundable contribution of €30.00. The amount must be credited to the bank account in the name of the Higher Institute for Artistic Industries of Florence at Banca Intesa Sanpaolo, Headquarters of Piazza della Porta al Prato Florence, IBAN code IT63F0306902992100000300003, indicating the reason "admission contribution competitive procedure doctorate a.y. 24 25". Refund of the contribution is not permitted under any circumstances. The candidate will be considered duly registered and therefore admitted to the competition only after making the payment of the contribution;

**d)** research project, written in Italian or English, in pdf format, which must include:

- d1) description of the project;
- d2) contextualization of the topic;
- d3) methodologies;
- d4) expected results;
- d5) brief bibliography.

The maximum length must be 5,000 characters (including spaces and notes) for all the points indicated with D, excluding bibliography and images. The project will be evaluated solely for the purpose of admission and does not constitute a binding commitment for doctoral research.

3.1.3 Additional evaluable qualifications and attachments:

a) other educational qualifications deemed useful for evaluation, specifically:

- Specialist/Master's/Old-system degree;
- Second-level AFAM diplomas;
- Relevant First-level Master's degrees;
- Relevant Second-level Master's degrees;
- Specialization or advanced training courses.
- Language certifications for languages other than Italian and English, to which certificates and self-certifications must be attached.

**b)** audio/video/images (URLs on a platform such as Vimeo, YouTube, Google Drive, or other similar platforms, maximum 5 URLs) and project documents (max 2 project documents in PDF format);

**c)** summary of the thesis or diploma, for those who have completed a thesis at the end of the master's degree or second-level diploma, in Italian or English, with a maximum of 4,000 characters including spaces, accompanied by a summary bibliography of the thesis with a maximum of 500 characters including spaces; in case the title has not yet been obtained, the summary of the thesis in progress must be attached, countersigned by the thesis advisor, under penalty of non-evaluation of the title;

**d)** scientific or artistic publications, for which the year of publication, the publisher, the name of the journal, and the ISSN, ISBN, or ISMN code must be indicated in the table attached to the application form. The omission of information declarations and the failure to submit mandatory documents at the time of completing the competition application cannot be rectified after the deadline for the call. application includes uploading empty files or files containing information of a different nature from what is

required. ISIA Istituto Superiore Industrie Artistiche di Firenze may also order the exclusion of candidates from the competition after enrollment and the start of the course if their documentation presents deficiencies in the prescribed requirements or if their self-certifications are found to be false. If the candidate is excluded after admission to the course, they are required to reimburse the scholarship installments they may have received. Exclusion is ordered by decree of the Director. The documentation must be complete with all the necessary elements for evaluation; documents with incomprehensible or illegible information will not be considered.

#### **ART.4 – ADMISSION EXAM**

1. Access to the doctoral course is granted upon passing the admission exam, which ascertains, through an appropriate comparative evaluation, the basic preparation acquired, the candidate's ability, and aptitude for scientific/artistic research.

2. The admission exams are conducted based on qualifications, a research project, and an oral test. The oral selection test will take place exclusively in person at ISIA Istituto Superiore Industrie Artistiche Firenze on the date and time specified in art. 5 of this announcement. Personal communications will not be sent to candidates. The judging panel has a total of 100 points available.

The scoring is distributed as follows:

**a.** EVALUATION OF QUALIFICATIONS: maximum score 20/100 (minimum score to access the oral test: 12/20):

- A. Degree or qualification for admission;
- B. Curriculum Vitae et Studiorum;
- C. Additional degrees and attachments;

**b.** EVALUATION OF THE RESEARCH PROJECT: maximum score 30/100 (minimum score to access the oral test: 18/30). The following will be evaluated: linguistic accuracy and clarity, originality, methodological approach, reference bibliography, and expected results. The research project must be presented following the indications of art. 3, no. 2, letter d, of this announcement;

**c.** ORAL TEST: maximum score 50/100 (minimum score to pass the oral test: 30/50). The oral test will be conducted in Italian or English. The interview will focus on the research project presented by the candidate, the candidate's educational background, and the research topics related to the proposed project.

The following will be evaluated: research aptitude, skills, and the candidate's knowledge. During the oral interview, the Committee will, at its sole discretion, assess the candidate's adequate knowledge of the English and Italian languages. One of the two languages (English or Italian) must be at level C1, and the other at level B2. If the knowledge of the Italian and English languages is found to be at a level lower than that required by the Announcement, this will be grounds for the Committee to declare the candidate unfit, and therefore, the candidate will not pass the oral test.

## ART. 5 – INSTRUCTIONS FOR THE EXAM

1. For the conduct of the oral test, the qualifying candidate is required to present themselves on September 17, 2024, at 10:00 AM at the ISIA headquarters at via Pisana 79, Florence. The candidate must identify themselves before the interview begins by presenting a valid identification document. If necessary, the oral test may continue on subsequent days.







Failure to attend, the unavailability of the candidate on the scheduled day or time, or the failure to present a valid identification document will result in exclusion from the selection procedure.

The lists of candidates admitted to the oral tests will be published on the page dedicated to doctorates at http://isiadesign.fi.it/dottorati-afam/ at least five days before the date of the oral test. Such publication has the full effect of a notification of summons.

The merit ranking, formulated based on the total score obtained by each candidate, will be published at the address: http://isiadesign.fi.it/dottorati-afam/

## **ART. 6 – THE JUDGING COMMISSION**

1. The Commission for admission to the doctoral course is appointed by Decree of the Director of ISIA Istituto Superiore Industrie Artistiche Firenze, in accordance with current regulations.

2. The composition of the Commission can be consulted on the institutional website at the following address: http://isiadesign.fi.it/dottorati-afam/. The Commission holds preliminary sessions, also via telematics, to exclude the existence of situations of incompatibility between them and the candidates, pursuant to articles 51 and 52 of the Code of Civil Procedure, as well as to evaluate the qualifications and research project presented by the candidates, assigning them a score that allows their admission, or not, to the oral test.

At the end of the oral test, the Commission drafts the ranking and transmits the minutes of the sessions to the Director who, by decree, approves them. The examining Commission has full responsibility for the proper conduct of the selection procedures, with particular reference to the correct allocation of scores as well as the correct drafting of the competition minutes.

#### ART. 7 – RANKING

1. The examining committee expresses a judgment of suitability for each candidate for the purpose of assigning positions in the general merit ranking.

2. Research scholarships are awarded based on the general merit ranking, identifying the winners among the top ranked of those who have obtained the judgment of suitability.

3. Following the publication of the oral exam results, the decree of approval of the acts containing the final ranking will be drafted and can be consulted on the dedicated page of the ISIA Istituto Superiore Industrie Artistiche Firenze website.

4. In case of a tie, the following criteria will be applied:

**a)** The evaluation of the less favorable economic situation, determined pursuant to DPCM of December 5, 2013, no. 159, art. 8, paragraph 4, shall prevail, in case of further tie, the younger candidate will prevail.

**b)** The winners of the competition must confirm the acceptance of the position within 48 hours of the publication of the ranking by sending a certified email to segreteria@pec.isiadesign.fi.it. The scrolling of the ranking occurs following an expressed or implied renunciation of the position, until the position expires. In case of scrolling, the position covered by the scholarship will be proposed to the suitable candidates according to the order of the ranking. Doctoral scholarships cannot be awarded to doctoral students who have renounced scholarships funded by the PNRR under the XXXVIII cycle and the XXXIX cycle.

## ART. 8 – CANDIDATES WITH DISABILITIES AND SPECIFIC LEARNING DISORDERS (SLD)







1. Candidates with recognized disabilities pursuant to art. 3, paragraphs 1 and 3, of Law No. 104 of February 5, 1992, or with a certificate of disability who, for the purpose of taking the exam, need special aids or extra time, must make a request, sending the documentation certifying the recognition of the disability or the certificate of disability. Such request must be sent together with the application for admission, along with the following documentation:

**a.** Diagnosis of Specific Learning Disorders (SLD), in accordance with Law No. 170/2010, issued by the National Health Service, an accredited private center, or a private specialist, accompanied by a conformity document issued by the National Health Service. The documentation must be no older than three years or issued after the candidate's 18th birthday;

**b.** Documentation, issued by a National Health Service specialist, attesting to another type of specific developmental disorder that affects learning;

c. Certification of handicap in accordance with Law No. 104/92;

d. Certification of civil disability;

**e.** Medical documentation, drawn up by a specialist, attesting to the presence of health conditions (physical and/or mental) that may result in an inability, even temporary, to study and take the exam. The overall documentation produced must be clear and contain useful information to understand the candidate's specific needs (Note: if the candidate has both the certification pursuant to Law No. 104/92 and additional medical documentation, they may submit everything they deem useful).

2. Candidates with disabilities or SLD residing in foreign countries who wish to benefit from adjustments must present legalized certification (or with apostille, where applicable) attesting to the state of disability or SLD issued in their country of residence, accompanied by an official translation in Italian or English. The certifications are examined by the competent structures to verify that the documentation attests to a condition of disability or specific learning disorder recognized by Italian regulations. The documentation is reviewed to assess the consistency of the adaptation requests with the documentation presented. In case of incomplete or illegible documentation, an integration will be requested, which must be sent within the mandatory terms specified in the communication. If the candidate does not submit the request for adaptations within the deadlines indicated by the notice or does not provide any additional required documents within the specified time frames, it will not be possible to grant the requested adaptations.

#### **ART. 9 – ENROLLMENT IN COURSES**

1. Those who have accepted the scholarship will receive communication with the necessary information for enrollment. The enrollment procedure is considered complete upon payment of the regional fee due to ARDSU Toscana, the stamp duty, and the insurance, according to the instructions published on the website of ISIA Istituto Superiore Industrie Artistiche Firenze http://isiadesign.fi.it/dottorati-afam/

Public employees admitted to the doctoral courses are subject to art. 12, paragraph 5 of D.M. 226/2021 and other applicable provisions.

#### ART. 10 - REGIONAL FEE FOR ACCESS AND ATTENDANCE OF COURSES





1. Doctoral students are required to pay the stamp duty ( $\leq 16.00$ ) and the regional fee for the right to study, the amount of which, unless otherwise determined by the Region of Tuscany, is set at  $\leq 140.00$ .

The following are exempt from paying the regional fee for the right to study:

- the winners and eligible candidates in the ranking for the scholarship of the Regional Agency for the Right to University Study;
- students with disabilities, with recognition of handicap (art. 3, paragraph 1, of Law No. 104 of February 5, 1992) or with a disability equal to or greater than 66%;
- students who are children of holders of disability pensions (art. 30 of Law No. 118 of March 30, 1971).

Admission to the years following the first and the final exam are subject to verification of payment of the regional fee.

#### **ART. 11 – SCHOLARSHIPS**

1. Scholarships are awarded as specified in art. 7. In case of a tie, the assessment of the more disadvantaged economic situation prevails pursuant to D.P.C.M. of December 5, 2013, no. 159, based on the Equivalent Economic Situation Indicator (ISEE) Certificate valid for subsidized benefits for university study. The annual amount of the scholarship is €16,243.00 (gross of social security charges borne by the recipient).

2. Admission to the doctoral course requires an exclusive and full-time commitment from the doctoral student. Concurrent enrollment in other academic courses is permitted under the conditions regulated by Law No. 33 of April 12, 2022, art. 2, paragraph 2, and by DDMM 930/2022 and 933/2022.

3. Cases of total or partial incompatibility for the enjoyment of the scholarship are established by current regulations. In particular, scholarships cannot be combined with research grants or other scholarships awarded for any reason.

4. Scholarships have an overall duration of at least three years and are renewed annually, provided that the doctoral student has been admitted by the Doctoral College to the following year, after verifying the regular and profitable completion of the activities scheduled for the previous year.

5. In addition to the scholarship and within the financial resources available in the budget, each doctoral student is assured, starting from the first year, a budget for research activities in Italy and abroad determined for each course in the amount of 10% of the gross annual amount of the scholarship.

6. Pursuant to DM 470/2024, art. 11, paragraph 5, "Public employees admitted to a doctoral course benefit, for the normal duration of the course, from the leave provided for by collective bargaining or, if they are public law employees, from extraordinary leave for study purposes, compatible with the needs of the administration, pursuant to article 2 of the law of August 13, 1984, no. 476, with or without pay and unless explicitly waived, only if they are enrolled for the first time in a doctoral course, regardless of the disciplinary field. The right to the budget for research activities conducted in Italy and abroad, as referred to in article 9, paragraph 4, remains unchanged."

7. Those who have already benefited, even partially, from a scholarship for attending a doctoral course, cannot benefit from it a second time.

8. ISIA Istituto Superiore Industrie Artistiche Firenze may not be able to disburse the scholarship to students from countries subject to restrictions ("embargo") until the residence permit is obtained.







# ART. 12 – AWARDING OF THE DEGREE

1. The title of Doctor of Research is awarded—jointly with partner institutions—upon passing the final exam. The doctoral student is required to upload the doctoral thesis, in electronic format, to the specific digital archive of ISIA Istituto Superiore Industrie Artistiche Firenze, according to the instructions that will be provided.

# ART. 13 - INTELLECTUAL PROPERTY OF RESEARCH RESULTS AND PUBLICATIONS

1. The intellectual and industrial property rights on any results achieved by the doctoral student are regulated in accordance with current legislation (Copyright Law - Legislative Decree 633/1941 - and Industrial Property Code - Legislative Decree 30/2005 and subsequent amendments), based on what is established in the individual agreements with ISIA Istituto Superiore Industrie Artistiche Firenze, the Companies, or Entities involved.

The inalienable moral right of the doctoral student to be recognized as the author or inventor remains unaffected. The doctoral student is required to sign a confidentiality agreement regarding the information, data, and documents of a confidential nature that they may become aware of in the course of their activities. In any case, the doctoral student is guaranteed the possibility to carry out the usual publication activities provided for by the training program, which must be scheduled in a manner compatible with the protection of any results.

# ART. 14 - PROCESSING OF PERSONAL DATA

1. The personal data related to this procedure are collected and processed for institutional purposes of the University in accordance with Articles 13 and 14 of EU Regulation 2016/679 - General Data Protection Regulation (GDPR).

2. Candidates have the right to access their personal data, to request its rectification, deletion, limitation of processing, as well as to oppose its processing by addressing requests to the following email: segreteria@pec.isiadesign.fi.it

3. In addition to protections in administrative and judicial matters, an appeal to the Privacy Authority is allowed: https://www.garanteprivacy.it in case it is believed that the processing violates the EU Regulation.
